

EWU MOT Applicant Observation Experience Log

The observation experience log is required by the EWU Department of Occupational Therapy. To apply, applicants are required to complete 40 hours of observation/shadowing/volunteering/working with individuals with disabilities. A sum of 10 hours **MUST** be with an occupational therapist. It is recommended you complete the observation experience in more than one practice setting but not required. Observation hours should be completed within 5 years of application submission date.

Directions:

- 1. Upload the completed observation log sheet as a PDF in OTCAS under the <u>Documents</u> section in OTCAS.
- 2. Additionally, Input the 40 hours as well as any additional experiences within the Observation section in OTCAS.

Experience log requirements:

- 1. Date of experience. If you observe at the same location more than one day, please indicate the dates and hours of each observation experience.
- 2. Number of hours completed.
- 3. Site specific information:
 - a. The facility name AND setting type
 (Example: Outpatient: Pediatrics, Schools: Pediatrics, Acute Care: Through the Lifespan, Inpatient Rehabilitation: Adults, Inpatient/Outpatient: Through the Lifespan, Inpatient Mental Health: Adults, Inpatient Hospital Mental Health: Adolescent, Skilled Nursing Facility: Older Adults, Home Health: Adults, Other (Please Specify)
 - b. Supervisor name and contact information (phone number OR email address is acceptable)
- * Failure to complete any of the instructions above will result in an incomplete application.
- * Other log formats are acceptable if they include all required information.
