Campus Safety and Operations: \$1,378,997

Funds used for PPE, purchasing of cleaning supplies, labor costs involved in cleaning and reconfiguration of physical spaces for social distancing, costs of COVID testing and vaccination.

Purchasing, leasing or renting additional equipment of software to enable distance learning including upgrading campus wi-fi access: \$12,699

Funds used to create campus hybrid learning environment for enhanced distance learning. Funds used for supplies, hardware and software, audio and visual equipment.

Replacing Lost Revenue from Academic Sources: \$6,700,000
